R1: #5 "Silverdart" (B. Cheyne – 5th) hopped at start.

R2: #2 "Buff Bay" (J. Crawford – 1st) was away slowly, prevailed.

Stewards spoke to Jockey Kirk Johnson about having continued to urge his horse, who was not responding, and trailed throughout the stretch.

R3: Clear.

R4: Ruling# 3899033: Trainer Julie Mathes assessed a monetary penalty of \$100 for her horse arriving late to the paddock prior to Race 4. AGCO Rule 11.01

Ruling# 3899015: Trainer Daniel Wills assessed a monetary penalty of \$100 for his horse arriving late to the paddock prior to race 4. AGCO Rule 11.01

#2 "Wild Houdini" (C. Douglas – 8th) dwelt at the start.

#9 "Whiskytangodisco" (P. Mailhot – 3rd) hit the side of the gate.

R5: INQUIRY / Jockey Claim of Foul: Incident entering the turn. Riders of #1 "Fairhope curly" (M. David - 3rd PL 2nd) and #4 "Fifty BMG" (K. Johnson – 2nd PK 5th) claim foul on #6 "Back to Reality" (S. Vives - 1st), alleging interference. Spoke to the a/n three jockeys as well as J. Crawford aboard #3 "Forest Flash" (5th PL 4th). Reviewed available video angles. #6 stays well off the other horses and is not at fault. #4 does bear in and impede the inside horses, #1 and #3, both of whom take up and lose ground. As a result. #4 is disqualified from 2nd and placed 5th, behind #3.
